SUPERTALK 99.7 WTN'S "JOURNEY 8/12 TICKETS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WWTN ("Station"), owned and operated by Cumulus Radio LLC, located at 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **SuperTalk 99.7 WTN's "Journey 8/12 Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
