SUPERTALK 99.7 WTN'S "ENTER TO WIN TICKETS TO SEE THE ROLLING STONES" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WWTN ("Station"), owned and operated by Cumulus Radio LLC, located at 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **SuperTalk 99.7 WTN's "Enter to Win Tickets to See The Rolling Stones"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
